教育局學生津貼（2023/24 學年）

敬啟者：

於 2019 年 8 月公布的 191 億元紓困措施當中，建議在 2019/20 學年為中學日校、小學和幼稚園學生提供一次性 2,500 元的學生津貼，以減輕家長在教育支出方面的財政負擔，這項津貼由 2020/21 學年起恆常化。茲將該津貼申請細則詳列如下：

### 資格準則

學生津貼不設資產審查。所有於申請日在香港提供本地或非本地課程的中學日校、小學和特殊學校（包括公營學校、直接資助計劃學校、英基學校及私立學校）及幼稚園（不論是否參加幼稚園教育計劃）就讀的學生皆可獲得有關津貼，但夜校學生、自修生、持學生簽證來港就學及持有入境事務處發出擔保書（坊間一般稱為「行街紙」）的學生則不屬資助範圍。

### 派發紙本申請表格

教育局會透過本校於 2023 年 10 月 6 日（星期五） 派發紙本「學生津貼」申請表格及核實學生身份。

申請表格分為表格 B（樣本見附錄一）和表格 A（樣本見附錄二）。表格 B 已預印學生及申請人的基本資料（原校升讀的學生適用）；表格 A 屬空白表格（本學年取錄的新生或轉讀他校等學生適用）。

填妥的申請表格必須透過學校交回教育局，本校會於每份學生津貼申請表格的指定位置蓋上學校印鑑，以確認該學生為本校學生。學校須於 11 月 8 日或之前將已填妥的表格交回教育局跟進。家長應透過學校將已填妥的申請表格送交教育局特別職務辦事處。

### 填寫申請表格


由於家長一般擁有本地銀行戶口，教育局會透過銀行轉賬向家長發放津貼。
